



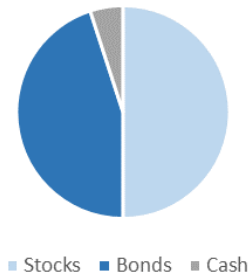
## WCM Disciplined Yield Balanced Growth Portfolio

### A global multi-asset total return portfolio emphasizing yield and stable dividend growth

The primary investment objective of this strategy is to balance growth of capital and dividends through global equity and corporate security exposure with the relative safety of government securities.

Balanced Growth



The long-term strategic asset allocation for this strategy is 50% global equities, 45% fixed income and 5% cash.

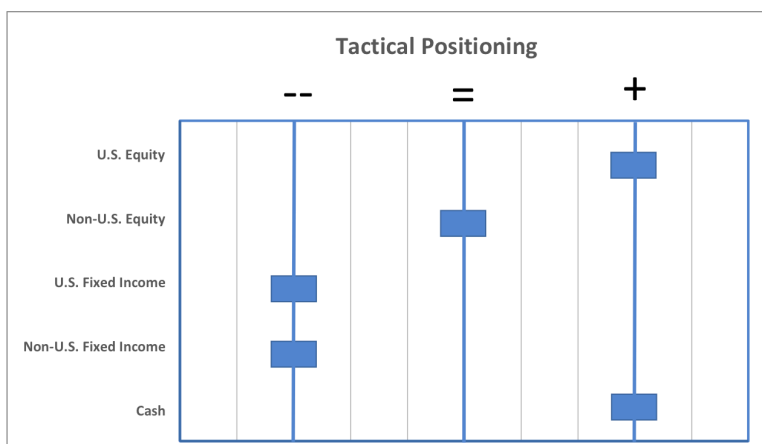
