



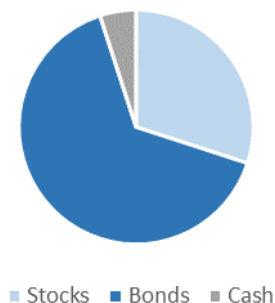
WCM Disciplined Yield Income & Growth Portfolio

The long-term strategic asset allocation for this strategy is 30% global equities, 65% fixed income and 5% cash.

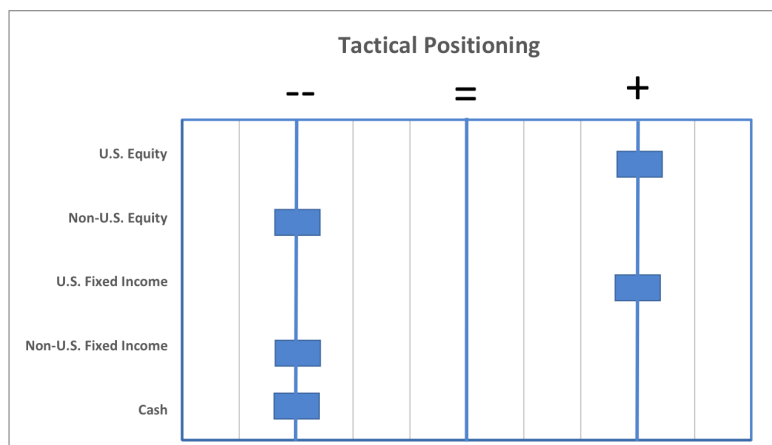
